ABGA Sanctioned Show Applications must be submitted to the ABGA office no less than 120 days prior to the show.

Submit one application for each proposed show.

The Sanctioned Show Program is designed to encourage the exhibition, marketing and promotion of ABGA percentage, purebred, and full blood Boer goats. Any show receiving ABGA sanctioning shall be open to all registered Boer goats that meet the requirements of the ABGA show rules. Ennoblement points earned at ABGA Sanctioned shows will not be awarded until **after** the Judges Evaluation form and Show Evaluation form are received at the office. These forms and a copy of the ABGA Rules and Regulations are included with the sanctioned show packet that you receive after your show is sanctioned. That the American Boer Goat Association, its officers, directors, agents, employees and volunteers (hereafter collectively known as "ABGA") shall not be held responsible for any loss, injury or damage in connection with, arising out of, or incident to said show. I further and hereby expressly waive all rights to claim against ABGA and I release ABGA from any liability whatsoever with respect to any injury to person or damage to or loss of property from any cause whatsoever (expressly including ABGA's negligence).
2. That said show will abide by and remain in accordance with the ABGA Sanctioned Show Rules and to have a copy of the rules available in the event that any problem or question should arise during said show.
3. To provide an ABGA approved judge to judge my show(s).
4. To report the judge's name to the ABGA office no less than 30 days prior to the entry deadline.
5. That, in accordance with the ABGA Sanction Show Rules, I must submit show results to the ABGA office to be verified within 30 days of the conclusion of the show.
6. That ennoblement points earned at my show will not be awarded to exhibitors until after the office has received the completed show evaluation form from the judge, and the judges evaluation form from me.

I understand that the ABGA has the right to decline sanction for this show. The ABGA office will send notification of sanctioning approval or denial to the show secretary. This notification may be made to the show secretary's email address, if provided.

By signing this agreement, I certify that all information submitted is true and correct, and that I will comply with all the requirements of conducting an ABGA Sanctioned Show and all of the statements above.
