JABGA Wether Incentive Program

Name Options

Boer Goat Advantage Incentive Program – BGA

Overview -

Wether incentive program that helps breeders and junior exhibitors to promote the American Boer Goat in the show wether side of the industry.

- -Allows for marketing opportunities for both the association and breeders.
- -Adds value for registered & percentage bucks
- -Brings in more JABGA members
- -Provides added value for registered stock to more outlets
- -Adds value to being an ABGA member and marketing opportunities

Procedure

Breeder registers wether and tattoos or microchips the animal

- -\$15 registration fee
 - -\$5 of that fee goes toward a specific incentive fund

Rules

- -No more than 1 year old, papers are destroyed after 1 year, no adult teeth
- -Tattoo or microchipped must be checked and verified against papers for cash prizes

Prizes

- -Added money for BGA wethers at Regional shows and Nationals
 - -large check (marketing)
 - -banner
 - -embroidered jacket
- -County Fairs, Majors, etc
 - -send in a photo get a vinyl banner or JABGA gear
 - -similar to show feed incentive programs

Considerations

-buck to wether papers

- -require transfers (we need to work on online transfers to non-members)
- exhibitors the owners
- -must the owner be a member?

Future Opportunities

- -Bred and Owned wether
- - -BGA breeder online sales
 - -get BGA incentives in majors
