B. DNA

- 1. ABGA is currently using UC Davis, which utilizes microsatellite technology
 - a) Only detects parentage using few markers (12)
- 2. Neogen is far superior
 - a) Parentage tracking is much more advanced
 - b) Higher accuracy with SNP (single nucleotide polymorphisms) tests than with microsatellite technology
 - i. Utilizes a minimum of 78 markers for parentage
 - c) Many other options and chances to build greater amounts of data
 - i. SNP tests provide information that we can use to further improve genetic selection once traits are identified
 - ii. Provide breeding based on genotype as well as phenotype

Auxiliary Document #1

I met with my special committee group last week and discussed the process we implemented in August and ways to improve it going forward.

Content of new policy

Judges to complete annual membership renewals in January of each year, along with annual code of conduct policy, at which time they agree to annual background check.

Annual background check must be completed within 30 days of membership renewal

Annual background check process will be administered through a safe and secure 3rd party vendor such as "Good Hire". The request for the background check will be sent individually from the ABGA office and the payment of this service will be covered by ABGA. The individual ABGA judge is required to complete the background check upon receiving the request from ABGA within the 30-day window = failure to comply will result in removal from the ABGA certified judges list until it is completed.

The results of the background check will only be seen by the individual judge and the office manager at ABGA, no additional sharing or storing of information of individual background check results may occur, with the exception of the following offenses if they appear on an individual's background check: Felony offenses or any Sexual or battery related chargers. If any of these types of charges are found on an individual's background check, they are cause for immediate removal and revocation from the ABGA Judges list. In the event of a revocation of judging rights occurs, the following individuals must be informed within 24 hours: ABGA Executive Director, ABGA President of the BOD, and the head of the ABGA Judges Committee and all necessary communications to take place in "Executive Session" in the event of a revocation taking place the results will be stated in the next BOD minutes, with only reference to an individual member's number. The length and the severity of the punishment will be determined by a majority vote of the ABGA BOD.
